survey responses that CSC and TUPA gather on behalf of Hanken School of Economics. The information includes:

- a) Form identifier/code of electronic response, response time
- b) Identification information that is not saved with the responses and which is solely used for administration of the target group and postage and gathering of background information.
  - First name, last name, personal identification number, possible date of death
  - Address, postal code, phone number
  - Student number/student identification number
- Background information that is saved together with the survey responses
  - Gender, nationality, tuition fee obligations, mother tongue
  - Code of municipality of residence, municipality of residence, postal code, state, home municipality code, mother tongue of the address
  - level of degree (according to VIRTA database), major, municipality of studies, code of municipality of studies, grade (approved/not approved)
  - University, starting year of studies, home municipality, graduation month, duration of enrollment, duration of presence, field of education (level 1, 2, 3)
- d) Respondents who wish to receive additional information about where the results are published can provide their email address while responding to the survey. The email address is saved separately from the survey's responses in the register of Hanken School of Economics.

## 7. Regular data sources

The background and identification information of the group of respondents will be gathered by CSC in a centralised manner from the national VIRTA study information service and, in supplementary parts, from the student information systems of universities (study subject, faculty). Address data will be supplemented using the Population Information System, and the telephone number will be acquired from the consumer information of the Suomen Asiakastieto Oy Service database. Email addresses are from Hanken School of Economics' alumni database.

The respondents can fill in a paper survey or an electronic online survey. TUPA registers the paper survey responses and CSC registers the electronic survey responses in the ARVO database. TUPA will gather both the paper and electronic survey responses in the register and combines with the background information.

TUPA will also combine the register of Hanken School of Economics to a national register by collecting the responses of all individual universities that oversee their individual registers. 	Based on subcontracting by Hanken School of Economics, the register is processed by TUPA, statistical research service of the University of Tampere, and CSC - IT Center for Science Ltd.
	CSC - IT Center for Science Ltd selects the target group, enriches the contact information, creates the survey links, and collects the online answers, as well as combines the material for reporting. CSC processes direct personal data during data collection and the survey data without the direct data when reporting the results. CSC discloses the personal data (contact information, background information and survey IDs) to TUPA so the survey and reminders can be sent and for analysis of the data.
	TUPA, statistical research service of the University of Tampere, coordinates the implementation of career monitoring and processes personal data in order to send the survey and for analysing and reporting purposes. TUPA discloses university-specific data to each university, to Aarresaari, career service network of Finnish Universities and to CSC for national reporting of national survey data. The data can be disclosed according to the contract of Hanken School of Economics to collaboration partners (such as professional associations) for research purposes, excluding any personal data from which data subjects can be directly identified.

## 13. Rights of data subjects

Under the EU's General Data Protection regulation (EU 2016/679), data subjects have the right to view their data, have their data rectified or erased, have the processing of their data restricted, object to the processing of their personal data, as well as the to lodge a complaint with the supervisory authority.

- Right to view data (right of access to personal data)
